

IMPORTANT!

FOSTER CARE TRANSITIONAL MEDICAID (FCTMA) ELIGIBILITY

- Begins at age 18 or older for youth currently exiting foster care.
- Is available for former foster youth under age 26, who exited foster care at age 18 or older.

YOUR FOSTER CARE WORKER WILL MAKE A REFERRAL FOR YOU AND...



Talk with you about receiving Medicaid until the last day of the month of your 26th birthday.

Explain the type of insurance you will receive, Medicaid Managed Care, by talking with you about this important brochure:

Give you a copy of the brochure so that you can make good choices about your health care.

WHAT IF MY FOSTER CARE CASE IS CLOSED AND I DON'T HAVE A WORKER ANYMORE?

First, contact your former worker and ask for his/her assistance. If unable to contact the worker, contact the DHS office in your county of residence. Ask to speak to the Foster Care Health Liaison Officer for information on Foster Care Transitional Medicaid.
